By accepting this agreement between you and HandsonERP.com, you are agreeing on following terms and conditions:

- For yearly subscription the term "period" refers to a "year".
- You can cancel subscription any time.
- The PayPal subscription is renewed automatically unless you cancel it. Once you cancel your subscription, you will not be billed for subsequent periods.
  - Fee for the period in which you have canceled is not refundable but could be adjusted for future subscriptions. The only exception is the point below.
    - Within four days of subscription renewal if you change your mind, you can cancel your yearly subscription and request a refund. You will be refunded the last yearly payment less \$20 administration fees. This option is only available at yearly subscription renewal. The refund will be processed on 14th day of the request. We will process the refund from our end if a request is made directly to us. If a dispute is opened with online merchant then both parties will stick to the decision announced by the merchant as the final decision.
